

# QUINTA DO REBENTÃO IN CHAVES INTERNAL RULES

## I

### ADMISSION AND REGISTRATION

- 1 – The attendance of Quinta do Rebentão -camping, designated for practising camping and caravanning on holidays, weekends and itinerant camping depends on the presentation of the National identity Camping Card or International Camping Card when obtained in foreign countries.
- 2– Minors under 14 , can only attend the camping when accompanied by their parents or by adults who hold themselves responsible for them.
- 3 – The National Camping card comprises the couple and children under 14 years of age.
- 4 – **Access to the camping is not allowed to :**
  - a) People carrying infectious/contagious diseases or diseases which can,in any way jeopardise sanitary order.
  - b) People under the influence of alcohol.
- 5– In agreement with the law, all users are forced to register.

The identification documents will be held and remain at the reception during the stay in the Camping.

## II

### VISITS

- 1 – Visitors to the campers are allowed as long as they present and leave a document of identification at the reception which will be returned after the visitor has paid the visitor's fee.The timetable for visits is from 9. AM TO 11.PM , and visitors can't stay more than (four) 4 hours inside the Camping.

### III

#### Rights

##### **1 – The users of the camping have the right to:**

- a) Use the respective installation and facilities in agreement with the present regulation.
- b) Know the prices of the camping, in advance
- c) Ask for the complaint book even if they are expelled from the camping.
- d) Ask for the regulation of the site.
- e) Preserve the housing tent.

### IV

#### DISCIPLINE

1 – In the Camping , there is a need to express a good and healthy relationship which will contribute to good relations between all members.

##### **2 – Therefore campers aren't allowed to do the following:**

- a) Use a language, vocabulary or practise acts which aren't in agreement with the rules of good education, and good manners.
- b) Make noise between Midnight and 8. A.M.
- c) Use radios or other sound instruments, except when they aren't disturbing the other users.
- d) Language which isn't ethically correct.
- e) Destroy or damage trees or plants.
- f) Jump over the camping fences.
- g) Play with balls, etc. outside the designated areas.
- h) Build or place any kind of plastic, vinyl covering, etc, over the tents, caravans or kitchens as well as fences around them.
- i) Use wires or ropes , at a height inferior to 2 (two) meters from the ground.
- j) Leave fires, stoves, lights unattended during the night, due to the danger this represents.
- k) Light a fire outside the designated places for this purpose, without the permission of the management.
- l) Pour handwashing water or with any kind of waste on the ground.
- m) Throw wastes that pollute on the ground, as well as to pour liquids into the rubbish recipients.
- n) Leave open taps , damage the plumbing or other facilities.
- o) Use the spring for any other purpose other than getting water.
- p) Wash or hang up clothes out of the designated area.
- q) Children, under 10 aren't allowed to put the rubbish away.
- r) Plant or sow without permission.

- s) Make religious or commercial propaganda.
- t) Make petitions or subscriptions, without authorization.
- u) Hang pictures or writings without authorization.
- v) Carry guns or dangerous instruments.
- w) Leave rubbish on the camping.
- x) Place different materials under caravans.
- y) Unleashed animals aren't allowed in the camping, their owners will be held responsible for the cleaning of the excrements of by their animals as well as their disturbance of the silence and peace.

**3 –Regarding materials, members are not allowed to:**

- a) Install tents, caravans or kitchens within a distance inferior to meters from each other (wall to wall) or in a way which obstruct or disturb the passage and freedom of other members.
- b) Install kitchens at 1 (one) meter from their own unit (wall by wall).
- c) Use materials that, by their aspect or condition, are against the principles allowed.
- d) Use as furniture, boxes, stones, bricks, etc. as well as, else that doesn't conform with the ethics of the campers.
- e) Leave sleeping bags, etc. spread out after 11 (eleven) o'clock.
- f) Leave tents empty for more than light days.

**4 – Regarding vehicles members are not allowed to:**

- a) Drive in the site, except for entering or leaving. In the special cases of bicycles, it depends on the permission of the management.
- b) Exceed the speed limit of 10 Km per hour inside the park..
- c) Park the vehicles outside the designated areas or in places where circulation will be difficult, or obstructed.
- d) Repair something without authorization.
- e) Wash outside the designated places.
- f) Blow the horn.
- g) Drive inside the park between 24.00 and 8.00 o'clock.

**V**

**DIFFERENT INFORMATIONS**

**1 –Users indentifications.**

All the users must keep any identification documents given by the camping and present it when asked, to do so by the authorized park personal.

## **2 – Identification of installed material :**

It is obligatory to hang the documents that are given for the identification of the units, in a visible place and, to return them at the moment of leaving the site.

## **3 – Complaints**

Complaints should be written in a book of complaints, that is at the disposal of the user.

## **4 – Responsibilities**

The Administration of the camping, declines any responsibility, including the identification or investigation of the authors of accidents ,damages, thefts or robberies that may occur to the users of the Park.

The responsibility for these acts goes to their authors or to their legal representatives, in case of minors.

## **VI**

### **PROTECTION SYSTEM AGAINST FIRE**

1 – The protection against fire is done by emergency doors and fire extinguishers in which the camping personal is instructed.

### **SANCTIONS**

1 – Non-compliance with the norms of admission and registration, as well as the disrespect of the norms of this regulation, will bring about sanctions that can go as far as expulsion from the site. In agreement with the 23° article of the legal Decree n° 33/97.

In this case, the identification documents of the camper will be withheld. During their withholding and , until superior decision, the attendance of the site isn't allowed.

2 – The intervention of the police may be called for to enforce these determinations, in agreement with the 50° th article of the legal Decree n° 127/71 6 April.

3 – The responsible of the site has the power to represent the Administration, make the decision come from them.

### **UNFORESEEN**

In cases not foreseen, the Administration of the site is going to resolve them, having in attention the principles expressed in this regulation and in legal Decrees the n° 38/80 and 33/97.
